Dolce Babies Suzuki Music Class for Baby and Parent Policies

Eligibility

- Only one child may attend with one parent. Both parents may attend with a single child, but two children may not attend with one parent.
- One parent must attend the entire class with their child. No child may attend class alone, regardless of age.
- Children ages 3 weeks *through* 3 years (up to age 4) are eligible for participation.
- Guests (other parent, grandparents, etc.) may attend class free of charge. All guests are expected to participate in the class.

Schedule

- Class dates, vacations, holidays and studio events are all detailed on the studio calendar on the website.
- This is a 12-month, year-round program. The class is most effective when attended regularly for three consecutive years.

Absences

- Student absences cannot be credited or refunded.
- If you must miss a class, you may attend another class session on another day during that same week, providing that there is space available.
- There will also be three make up class dates, spring, fall and summer, for those who have missed a class.
- If you must miss a class, please call or email. We will worry about your safety if you do not show up.

Payment

- This is a tuition-based program, not a fee-per-class program. Tuition is pro-rated over the course of the entire year, so the tuition is the same every month. You are not charged more for months that have 5 classes in them and neither are you charged less for months that have fewer classes.
- This is a continuous intake program, so enrollment may begin at any time. If you begin in the middle of a month, your first month's tuition will be pro-rated.
- Current prices are posted on our website, however, your tuition amount at the time of enrollment will remain in effect without increase as long as you are enrolled in the class without interruption.

- All fees are non-refundable.
- There is a \$20.00 late fee for late payments by cash or check. Payment is late if not received by the 1st day of the three-month period.
- There will be a \$35.00 charge for all returned checks.
- Credit card charges will be made on the first of the month. Charges will continue each month or three-month period (as specified) until Dolce Music Studio is notified otherwise.
- 30 days notice is required to terminate the charge agreement.
- Cardholder agrees to perform the obligations set forth in the cardholder's agreement with the card issuer and pay the credit card charges in accordance with the card issuer agreement.
- A chargeback fee will be applied (\$50.00 as of the time this is written), if you initialize a chargeback with your credit card issuer.

Illness

- Do not attend class when ill. Learning does not happen when you or your baby is sick. Please do not pass on contagious illnesses to the teachers, parents, and students in class and their families.

The Next Step

- It is assumed that when a student begins, that classes will continue until graduating from the class sometime between age 3 1/2 and 4. As that time nears, parents and students will begin observation of lessons in the private studio to prepare for the next step - beginning private and Suzuki group lessons on violin, viola, cello or piano.

Discontinuing Classes

- If it becomes necessary to discontinue classes, a 30 day notice is necessary.
- I may have to dismiss a student if any of the following circumstances occur: failure to pay tuition on time, failure to comply with studio policies, or uncooperative or disruptive attitudes from the student or the parents.
